New Module News

What's new at ECATTS, you ask? In addition to your numerous awareness modules, our team is hard at work developing two brand new, in-depth, multi-course certification modules. Both of these training curriculums are designed to offer you the knowledge needed to pass a certification exam or even obtain Continuing Education Units (CEUs). Expected release date of the new trainings is late Q1 2016.

New courses in development:

Underground Storage Tank Operator A/B Certification:

This course will consist of 17 modules with information based on the requirements established by the EPA and state regulatory agencies for UST Operators A/B. To facilitate your learning experience, each course is being developed with state-specific information and state regulations integrated into each module. Topics covered include operator overview, tanks and piping, ancillary equipment, spill and overflow prevention, tank gauging, release detection, statistical inventory reconciliation, secondary containment and interstitial monitoring, groundwater and vapor monitoring, corrosion protection, emergency response, product compatibility, notification and registration requirements, release reporting, closure requirements, and financial responsibility.

Backflow Prevention:

This training will consist of approximately 18 hours of in-depth training with content based on ABC Need-to-Know criteria, AWWA-M14 manual, and USEPA Backflow Prevention manuals. Training will include terminology, types of backflow prevention devices and assemblies, how they protect human health, overall functionality, equipment, testing, pros and cons, basic hydraulics of backflow backsiphonage and backflow backpressure, troubleshooting failed devices, and roles of the EPA, states, local government, public water system, and others that require backflow prevention devices or assemblies.

Cross Connection Control:

This training will also consist of approximately 18 hours of in-depth training with content based on ABC Need-to-Know criteria, AWWA-M14 manual, and USEPA Cross Connection manuals. Training will include terminology, public health significance, laws, regulations and policies, types of cross connections and where they are found, pros and cons, theory of backflow, degrees of hazards, methods of protection, how to develop a cross connection control program plan, and roles of the public water systems, plumbing inspectors, plumbers, states, local government, and others to control cross connections.
