SPCC Plan Templates Now Available

In June 2012, the Navy identified an unmet training requirement on Spill Prevention Control and Countermeasures (SPCC) plans. The NAVFAC HQ SPCC Program Manager presented this issue to the Navy Environmental Readiness Training Program (NERTP) Steering Committee. The NERTP Steering Committee determined that the most cost effective way to provide SPCC plan training, Navy wide, was to develop a site-specific SPCC Plan Template that could be completed by the Installation SPCC Manager and uploaded into ECATTS for all personnel who have this training requirement.

The Navy's Petroleum Oil and Lubricants Media Field Team developed the SPCC plan template and it was sent to the NAVFAC Environmental Compliance Directors in April 2014. The template addresses the training needs of 40 CFR 112.7(f)(1) and (3).

SPCC PMs that need the template can contact ECATTS Support at **support@ecatts.com**. Once the template is completed, send to **support@ecatts.com** to be uploaded to your ECATTS site and added to personnel's Individual Training Plans.
