Updated Trainings Include:

1. Storm Water Pollution Prevention Training for NAS Corpus Christi

- Why are we doing this training? To stay in compliance with 3 different permits/plans:
 - Multi-sector General Permit (MSGP) for Industrial Facilities
 - Municipal Separate Storm Sewer System (MS4) Permit
 - Storm Water Construction General Permit (CGP)

2. Environmental Management System (EMS) for NAF Atsugi

Why are we doing this training? OPNAVINST 5090.1 requirement: All Navy military, civilian, and contractor personnel should receive initial environmental awareness training and a refresher every 3 years.

3. 2025 Oil Handlers Training for NSA Annapolis

Why are we doing this training? 40 CFR 112.7(f)(1) requirement: All facility oil handling personnel on Installations are required to train in the operation and maintenance of equipment to prevent discharges; discharge procedure protocols; applicable pollution control laws, rules, and regulations; general facility operations; and the contents of the facility SPCC Plan.

4. Environmental General Awareness Training for Naval Air Station **Patuxent River Complex (NASPRC)**

Why are we doing this training? OPNAV 5090.1, Ch. 17 requirement: All Navy military, civilian, and contractor personnel must receive initial and refresher environmental awareness training as soon as practical after reporting to an installation or activity and at least every 3 years.
