Resource Conservation and Recovery Act (RCRA): 8, 16 & 24 Hour Training Manuals

Objectives: to understand the Resource Conservation and Recovery Act (RCRA) hazardous waste regulations and how to maintain environmental compliance. These trainings provide an overview of RCRA and educate on topics such as: the specifics of legislation and regulations, management and uses of hazardous waste, standards and restrictions, and the in between. These manuals cover material which is required for initial and yearly refresher training needs under RCRA, 40 CFR 262.34(a) and 40 CFR 265.16. This training is comprised of key topics that help prepare employees satisfy initial training rules and guidelines.
