Training Spotlight

We've been busy adding new modules for your training benefit. Look for the following on your site:

Introduction to Drinking Water: This 9 part series is an overview of issues and components pertaining to drinking water systems. Examples of topics covered include Safe Drinking Water Act, application of drinking water standards, the role of the states in Regulating Drinking Water, public water systems classifications, NPDWRs, Secondary Drinking Water Regulations, Exemptions, Testing, and Navy policy, contaminants and water protection, State requirements for water quality, treatment methods, distribution, Emergency Response Plan and necessary actions, and best management practices.

UST Class A/B Preparatory Program (*states of California & New York*): This 9 module curriculum provides an overview of UST operator roles, responsibilities, and requirements and prepares you for the UST Class A/B Operator Exam.

UST Class A/B Operator Certification Training (states of Maryland, Virginia, & Washington): Includes 9-11 modules thoroughly covering topics such as training requirements, spill and overfill prevention, release detection, corrosion control, financial requirements, emergency response, inspection requirements, and recordkeeping and reporting to name a few.
